### **CONCERNING ROYAL MARINE PO37596K ALAN ADDIS**

Alan Addis was a Royal Marine who went missing on August 8, 1980, while stationed in the Falkland Islands. His disappearance remains a mystery, and he is now widely believed to have been murdered, In North Arm, Lafonia, East Falkland Islands.

Alan was murdered because of a altercation with one or two locals. His death may have been accidental but all the same he was murdered.

Apparent witness a local shepherd by the name of Johnny Biggs about to give witness details of something he overheard or actually seen, was murdered when his bunkhouse was set ablaze so it looked like an accident. There also may have been a survivor of this fire (John Conquest) which today further details are unknown. There are also indications (not available publicly) that there was a second survivor. No formal interviews or investigations or officially acknowledged.

Another recently obtained view is that previous to NP8901 being posted from Stanley to North Arm there was a altercation / fight with a local lad in Stanley by Alan and other members of NP 8901. No Falkland Police report, No Royal Marine Police report available whatsoever.

This may have been the cause of the murder of Alan as when posted to North Arm some locals / relatives of the lad who was beaten up in Stanley sought vengeance that went to far, and Alan died.

I BELIEVE THAT NAVAL PARTY 8901 OF 1980, INCLUDING THE ORIGINAL FALKLAND ISLAND SUSPECTS, AND OTHER ISLANDERS TODATE ARE STILL CONCEALING INFORMATION THAT COULD ASSIST THE RETRIEVAL OF THE BODY OF ALAN ADDIS.
